Paid for by Kennedy Victory Fund 2024, a joint fundraising committee authorized by Team Kennedy and the Libertarian National Committee (LNC). The first \$6,600/\$10,000 from a person/multicandidate committee ("PAC") will be allocated to Team Kennedy, with the first \$3,300/\$5,000 designated for the general election and the next \$3,300/\$5,000 for the primary election. The next \$41,300/\$15,000 from a person/PAC will be allocated to the LNC. Any additional funds will be allocated to the LNC, subject to applicable contribution limits. The allocation formula above may change if following it would result in an excessive contribution. Notwithstanding the stated formula allocation, donors may designate their contributions for a particular participant or participants. Contributions will be used in connection with federal elections, may be spent on any activity as each committee determines in its sole discretion, and will not be earmarked for any particular candidate. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of individuals whose contributions exceed \$200 per election cycle. Kennedy Victory Fund 2024 does not accept contributions from corporations or their PACs, unions, federal contractors, national banks, those registered as federal lobbyists or under FARA, SEC-named executives of fossil fuel companies, or foreign nationals. Team Kennedy will continue to take contributions for the primary election until all net debts outstanding for the primary election cycle are paid. After this time, the allocation to Team Kennedy will only include the general election portion.

Federal law prohibits contributions from corporations, labor unions, federal contractors, national banks, and foreign nationals. All contributions must be made by personal funds, and they may not be reimbursed by any person or entity.
